Confidentiality & Minor Consent Laws in Illinois

Confidencialidad y leyes de consentimiento menor en Illinois

**Persons ages 12 and up have the right to the following
WITHOUT parental/guardian consent:**

- Pregnancy testing and prenatal care
- Birth control information and contraceptives
- Testing and treatment for sexually transmitted diseases (STDs)
- Substance abuse treatment
- Counseling and treatment of any disease or injury suffered from acts of sexual assault or abuse
- Mental health counseling*

* Up to eight, 90-minute mental health counseling sessions for ages 12-16.

Minors can access more than eight sessions if the provider believes it's in the minor's best interest to continue or that parental involvement would be detrimental to the minor's well-being.



MINORS NEED A PARENT/GUARDIAN'S CONSENT FOR:

- Inpatient mental health treatment (if under age 16)
- Starting at age 17, consent is not needed for inpatient mental health treatment, but parents may receive notification
- Vaccines

HEALTH CARE PROVIDERS MUST OVERRIDE THE MINOR'S CONFIDENTIALITY AND REPORT IF:

- There is suspicion of abuse by an adult
- The minor is a risk to themselves or someone else

If maximum confidentiality is important to an adolescent, then community-based family planning health centers (such as Title X clinics) offer the maximum privacy protections.

ABORTION SERVICES

A pregnant minor may consent to abortion services without parental consent. However, an adult family member—i.e., someone over 21 years of age who is the minor's parent, grandparent, stepparent who lives in the minor's home, or legal guardian—must be notified 48 hours before the abortion is performed. Please know you have other options that do not include telling your parents- it's called **Judicial Bypass**. For some minors, telling your parents about a pregnancy may lead to significant harms, including physical or emotional abuse, being kicked out of your home, being forced to continue the pregnancy against your will, or dangerous attempts to self-abort the pregnancy. Will County Safe Passage

Individuals suffering from an opiate addiction can seek assistance in accessing treatment from one of the participating police stations listed. The police will connect the individual with a trained volunteer that will personally escort the person to a licensed treatment facility. The police departments recognize that arrests don't help the opioid crisis. Participation in Safe Passage doesn't involve criminal charges nor require filing of a police report.

Well-Care Visits

Visita anual de bienestar con el médico

A well-care visit is an appointment with a health care provider that focuses on keeping teens healthy by addressing health risks before they are a big concern. All teens should have a well-care visit each year.

Well-care visits are 100% covered by health insurance (private and Medicaid). A well-care visit includes the following:

- Physical exam, height/weight and blood pressure checked
- Check for behavioral and mental health concerns
- Advice and support on staying healthy (e.g., healthy eating, physical activity, healthy relationships, stress management, dental care)
- Immunizations as needed

Request a well-care visit with your teen's doctor. If your teen does not have a health care provider, contact a local Federally Qualified Health Center who provide services on a sliding fee scale, based on your income.
