Accessing Care & Patient Responsibilities

A commercial answering service is utilized after hours, simply dial (815) 727-8670 for immediate access. Medical care for people of all ages includes preventive services, school, sports & pre-employment physical exams, immigration physicals, & of course treatment for all illnesses.

EMERGENCY CARE - Many injuries or illnesses are frightening, but not true emergencies. The hospital emergency room should only be used in severe lifethreatening situations. Responding quickly and remaining calm is difficult in emergent times.

REMEMBER your Doctor is available 24 hours a day and only a telephone call away. Always telephone the Health Center prior to using the Emergency Room, unless it is an extremely severe condition.

To make the most out of your appointment: -Arrive 15 minutes early. - Bring medication bottles and anything else you want to discuss. - Bring your photo ID, insurance card or proof of income (acceptable proof of income: pay stubs, tax forms, letter from employer, or other documents verifying amount of income).

If you cannot make your appointment, please call as soon as possible to reschedule. Please call if you are going to be late for your appointment. You may be asked • to reschedule or see another provider.

Fees, Payments & Health Insurance

As a Federally Qualified Health Center (FQHC), Will County Community Health Center offer discounts based on federally established guidelines. You may be eligible for a discount if you are not covered by an insurance plan.

Discounts are based upon family size and income.

Proof of income is required to be considered for a discount. There is a nominal \$25.00 fee due per visit, for medical, \$50 for dental. No one is turned away for inability to pay.

Most Laboratory services for self-pay patients ordered and processed at the clinic are eligible for discounts and are billed by the centers' contracted vendors.

This Health Center is a Health Center Program grantee under 42 U.S.C. 245b, & a deemed FTCA Public Health Service employee under 42 U.S.C. 233(g)-(n).
