- The annual report is expected to show the agency over on expenses and under on revenue. This is attributed to slower grant payments impacting cash flow.

D. ACCOUNTS RECEIVABLE

- The patient balance account receivable report shows a slight increase compared to the previous quarter.
- Current pending accounts receivable totals are as follows; Dental at \$109,00, up from \$100,000, Medical / Behavioral Health at \$332,000, up from \$280,000.
- Due to slower incoming funds from the grants, the agency will be focusing on the patient personal payments.
